Background</b></p> <p>The Division Roads and Transport Services (DRTS) requires a service provider to construct storm water structures on as and when required basis throughout the jurisdiction area of the municipality.</p> <p>Orders will depend on the works required. The BOQ quantities are only for evaluation purposes and each order may consist of only a number of items in the BOQ. Where possible labour to be sourced from local area through municipal structures.</p> <p><b>2. Specifications</b></p> <ul style="list-style-type: none"> <li>• The contractor must at all times exercise care while undertaking the work to ensure that trees, shrubs, hedges, flowers, etc. on the pavements or private properties adjoining the work areas are not unnecessarily removed or negatively affected by the work. Should any damages occur as a result of negligence on the part of the Contractor, he/she shall be responsible for costs in this regard.</li> <li>• The contract must ensure that adequate safety procedures are employed at all times when working on/next to public roads and storm water channels. The contractor should also issue the required safety/ protective clothing, tools and traffic signs required to perform the work. ### 3. Preliminary and General

The quoted rate includes full compensation for the Contractor's charges to complete the full task inclusive of Preliminary and General, labour, plant, material and all other cost associated with completion of the task. No additional payment will be made for any item in the task not listed but form part of the execution of the works.

### 4. Edge Beam Construction

- ❖ Saw cut exiting premix layer and base to 150mm. Depth of concrete, both edges for excavation.
- ❖ Excavate area square to depth of solid material. 200mm wide and 150mm deep.
- ❖ Ensure vertical sides to the required depth / inclusive of shuttering. Shuttering if required only on side furthest away from surfacing.
- ❖ Compact in- situ material layers to 93% MOD AASHTO. Only hand compaction method allowed. Care must be taken not to disturb the surrounding compacted layer.
- ❖ Concrete is to be compacted into the mould by any method that will ensure dense concrete. (Vibration when required)
- ❖ Concrete to be class 25Mpa.
- ❖ The concrete to be woodfloated.
- ❖ Concrete to be cured and protected against damage.
- ❖ Construction joint to be done every 5m.

### 5. Day Works

The day work rate will be used in accordance with the General Conditions of Contract (GCC 2010) clause 37.2, for the use in determining payment for work which cannot be qualified in specific units in the schedule of quantities, or work ordered by the engineer during the project which was not foreseen at tender stage and for which no applicable rate exists in the schedule of quantities. The Contractor and the Engineer will agree on the method of recording the working hours prior to the commencement of the work. Any long period of idling at any one time which in the opinion of the Engineer or his representative is beyond that required for normal operating conditions will not be paid. An instruction regarding all work to be carried out under day work in terms of Clause 37.2 of the General Conditions of Contract will be issued at the discretion of the Engineer. Non-working hours for any reason shall not be measured for payment.

Labour day rates for MCLM is R186/day.

**6. Contractor's Health and Safety Declaration**

In terms of Clause 4(4) of the OHS Act 1993 Construction Regulations 2003 (referred to as "the regulations" hereafter), a contractor may only be appointed to perform construction work if the employer is satisfied that the contractor has the necessary competencies and resources to carry out the work safely in accordance with the Occupational Health and Safety act no 85 of 1993 and the OHS Act 1993 Construction Regulations 2003.
