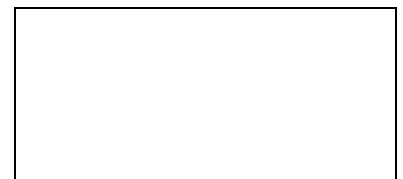

- (a) disqualify the person from the bidding process;
