Wooden Units 1. 1 x Single continuous wall mounted unit of size 4200mm wide x 1200mm high x 250mm deep manufactured in a glossy Cherry Wood appearance to accommodate two large electronic display centres complete with the same appearance doors constructed and fitted to open sideways in a controlled stackable manner. a. Door frames to be 75mm wide with a plane outer bevelled edge of 50 mm to a door thickness of not less than 16mm. b. Upper and lower doors to not exceed 400mm in width so as to not cause obstruction when in an opened position. c. Door frames and inside panels to be neatly flush on the outside. d. Doors to be guided at the top and bottom end with pre-manufactured rails and hinges of a high quality. e. 	5. All varnished and sprays to be applied to give a silk smooth glossy finish.
	B. <u>Sundry Items</u>
	 Lift carpet where indicated by the client and trench wooden floor to accommodate trunking (minimum 38mm wide to be installed for electronic equipment wiring, protected with a 1mm steel plate strip over the trunking and screwed to the wooden floor and then refix (glue) existing carpet to original state. Measure, manufacture and install a heavy duty metal inlay computer tray (inside dimensions: 600mm long x 450mm wide x 50mm deep) with appropriate entrance holes for electrical and computer wiring complete with lockable lid professionally covered with genuine black textured leather on the inside and exposed surface area. The computer tray lid shall be hinged at the back along the 600mm side and must be able to fold open backwards and flush with the table surface. The lock shall be installed in the front, also along the 600mm side
	 c. Installation will require an experienced cabinet maker to prepare existing boardroom table to receive the above-mentioned purpose made computer tray. Special care must be practised not to cause any damage the external surface and edges of the existing boardroom table. Exposed wooden areas where insertions are to be made must be sealed and covered for protection against possible water damp. All wiring underneath the table surface must be neatly secured and protected in appropriate trunking securely fitted to the footing of the table to prevent unnecessary damage to it. Fit under the table surface an appropriate 4x4 electrical power supply box for the computer equipment to be installed.
